# FINANCIAL UPDATE – JOHN HATFIELD

At the last Board meeting we met with our attorney Steve Ott to discuss the proper treatment of reserves. We reviewed all the actions we have taken since I became treasurer and received a full endorsement of all we have done. To review the full report of this meeting, please review the minutes of the August 13 Board meeting on our Blue Water web site.

Speaking of reserves, we have only spent \$4,000 of reserve money YTD. There are two major projects coming up this fall including sealing of Blue water drive and the repair and painting of pool furniture. As you know, every year we put \$60,000 into reserves and I am projecting we will spend under \$40,000 of that. That would mean we will restore the \$20,000 over expenditure last year and the reserve balance should return to the level prior to 2015.

# LANDSCAPING COMMITTEE – JOHN SHULEVA

While we enjoyed great summer weather, the 22 days of 90° F weather in 2016 has placed unusual stress on our trees and shrubs. We will begin to assess any damage in a walk-thru in early September. When plant replacement is recommended, the goal is to select plant material that has (a) relatively "high" drought tolerance and (b) adds some color to the overall landscape. Suggestions are welcome. A recent project entailed removing "old" plant material along the east side of the pool fence and replacement with knock-out roses and ornamental grasses. The new plantings will help facilitate the pool fence paintings to be scheduled this fall.
